2024 CAIP PROGRAM

The Breckinridge County Conservation District will be conducting the County Agriculture Investment Program (CAIP) #A2024-0012. This program is sponsored in part by the Kentucky Agriculture Development Fund (KADF). The Breckinridge County Ag Development Council set the cost share amounts as follows, Primary programs cost share of \$2,000; Secondary Programs cost share of \$1,000, for a MAXIMUM of \$2,000 for the combined programs.

- Any producers interested in improving their farm business must apply at the Breckinridge County Conservation Office between the dates of February 21, 2024 thru March 27, 2024.
- Applications can be picked up from 7:30 a.m. (ct) through 3:30 p.m. (ct); except office is closed for lunch from 11 am (ct) to 12 Noon p.m. (ct).
- All interested parties must pick up and return the applications for approval to the office, 1101 S. Hwy 261, Suite 102, Hardinsburg, during the above times.
- All returned applications will be scored and those approved for cost share funds will be notified no later than April 22, 2024, date subject to change.
- Receipts for cost share practices must be dated from January 1, 2024 thru October 4, 2024.

The cost share programs that may be approved with proper documentation are as follows:

- 1. Agricultural Diversification Secondary Program \$1000
- 2. Large Animal (beef, dairy, equine) Primary Program \$2000
- 3. Small Animal (goat, sheep, swine, bee, rabbits) Primary Program \$2000
- 4. Farm Infrastructure Primary Program \$2000
- 5. Fencing & On-Farm Water Primary Program \$2000
- 6. Forage & Grain Improvement Primary Program \$2000
- 7. Innovative Agricultural Systems Primary Program \$2000
- 8. On-Farm Energy-Primary Program \$2000
- 9. Poultry & Other Fowl Secondary Program \$1000
- 10. Ag Tech & Leadership Development Primary Program \$2000
- 11. Value-Added & Marketing-Primary Program \$2000

Important Dates; all review dates subject to change

- 1. Application time, February 21, 2024 thru March 27, 2024. You must fill out an application between these dates, no exceptions.
- 2. If you are approved, you will receive notice of approval no later than April 22, 2024.
- 3. <u>After notification of approval</u>, you can begin bringing in receipts for practices that have been completed along with proper pictures of projects and fill out a final report.
- 4. Receipts for cost share practices must be dated from January 1, 2024 thru October 4, 2024. All paperwork must be turned in to the Soil Conservation Office by October 4, 2024 before 3 p.m. (ct).
- 5. Pending review and approval of your receipts and final report, you will receive notification that your reimbursement is ready to be picked up.
- 6. If you receive notice that you are on the waiting list then you will be notified as money becomes available for you to complete your project for the CAIP Cost Share Program #A2024-0012.

Applicants must attend an educational class approved by the Breckinridge County Extension Office before receiving payment.

Please stop by the Breckinridge County Soil Conservation Office to pick-up the rules and applications for the programs.

CLOVER FROST SEEDING

Xtendimax, Engenia, and Tavium Availability in Kentucky for 2024

The United States District Court of Arizona vacated the 2020 Xtendimax, Engenia, and Tavium labels for use in dicamba-resistant soybean on Feb. 6, 2024. This order left the availability of the three products for the 2024 season in limbo for approximately a week. On Feb. 14, 2024 the EPA responded to the court ruling with an Existing Stocks Order allowing the sale and distribution of existing stocks of Xtendimax, Engenia, and Tavium. What does this all mean for the 2024 growing season and the use of these products? The following information is my interpretation of the EPA Existing Stocks Order and how it may affect Kentucky soybean growers in 2024. If you are in doubt about how to use a product in 2024 or how this order affects you, please refer to the EPA order or the products label, website, or representative. You can find the official EPA Existing Stocks Order at this link:

The order indicates that the sale and distribution of Xtendimax, Engenia, and Tavium will be allowed by persons other than the registrants until May 31, 2024 in Kentucky. "Persons other than registrants" would include co-ops, local dealers, and commercial distributors. Only product that was in possession of the "other persons" on or before the February 6 court ruling can be sold or distributed. While a majority of products were already in possession of these "other persons" or "in the channel", not all product was at this stage on February 6 and thus a full supply availability is highly unlikely to occur.

Furthermore, the order allows for the use or application of these three products by both private and commercial applicators in dicamba-resistant soybean fields until June 30, 2024 in Kentucky. This date aligns with the already established cutoff date for Kentucky.

Lastly, and most importantly, ALL APPLICATIONS OF XTENDIMAX, ENGENIA, AND TAVIUM MUST STILL FOLLOW THE RESTRICTIONS IMPLEMENTED ON THE MOST RECENT LABELS INLCUDING THE MANDATORY ANNUAL TRAINING.

AGRICULTURE SALES TAX EXEMPTION NUMBER PROGRAM

Does the AE Number have an expiration date?

- Yes, the current AE Numbers expire on December 31, 2026, and renewals from that date forward will expire after 4 years.
- The Department of Revenue will provide further details on the renewal process at a later date.
- A farmer with an AE Number must contact the Department of Revenue within 60 days after the farmer ceases activities that qualify the operation for an AE Number for cancellation purposes.

If you are going to be selling any of these animals you need to apply for a Premise ID. You need to fill out one of these forms and fax or e-mail it to address at the bottom of form.

THIS MONTH'S TOPIC WHEN AND WHERE TO GET MEDICAL CARE



The types of medical providers has changed rapidly over the past several years. From company name changes and insurance coverage shifts to pop-up clinics and telemedicine, it can be confusing to know which type of provider best suits your needs.

For serious emergencies, always call 911. For example, if you or a person in your care has any of the following:

- isn't breathing or is turning blue,
- is unconscious,
- is having a seizure,
- has a serious allergic reaction,
- has a broken bone that sticks out through the skin,
- took an unknown amount of medicine, or
- has a large cut that won't stop bleeding.

Other serious situations need medical attention but may allow for you to transport yourself or someone in your care to an emergency room (ER) or hospital emergency department (ED). Go to an ER if you or someone in your care:

- has trouble breathing,
- has a stiff neck and a fever,
- is experiencing a continuous fast heartbeat,
- ingested a poison, drug, or unknown substance,
- has a head injury and is vomiting,
- has an eye injury, or
- has a serious burn.

Call your primary-care provider's office with any health-related questions or nonurgent health concerns. They can help you decide what steps to take and how. Call for problems such as a fever, ear pain, a sore throat, belly pain, vomiting or diarrhea, a headache that doesn't go away, possible dehydration, rash, wheezing, or a lasting cough. Calling your regular provider for these kinds of concerns supports "continuity of care" (always seeing a provider who knows you).

If you cannot get to your provider's office or it is after hours and the office is not open, you can go to an urgent care center. Urgent care centers can manage the same problems as your regular health-care provider. These centers also can provide services like X-rays, stitches, and splints.

Telehealth, or telemedicine, are virtual "visits" to a health provider using your phone or computer through an app or website. You can talk to a provider face-to-face — and the provider can see you on the screen. Your regular health-care provider or health system may provide telemedicine services, and some health insurances offer telemedicine providers. You may want to consider a telemedicine appoint for problems such as:

- rashes
- minor cuts or burns
- pink eye (conjunctivitis)
- colds
- fever
- mild allergic reactions
- vomiting
- diarrhea

If you receive care in an ER, at an urgent care center, or through a telemedicine visit, follow up with your primary-care provider afterward. That way, your provider has the most up-todate information about your condition and can continue any needed follow-up care.

Spring Forward- Be Prepared

As March begins and winter starts to wind down, now is the time to start thinking about being prepared for what the unpredictable spring weather can throw at us. March is a transitional month where we need to be prepared for anything and everything. In recent years, we've seen snow and cold snaps, but we've also experienced flooding and tornadoes as well. March tends to represent the battle between winter ending and spring beginning. Eventually, as we move into April and May, signs of winter disappear and spring develops in full force.

Spring can bring beautiful weather, with warm temperatures and sunny skies - great to get the flowers blooming. But it can also bring violent, dangerous weather. Do you or your family know what to do if severe weather strikes where you are? Preparation can be key for everyone's safety!

Always be weather aware! Make sure you know the weather risks of the day ahead of time. When severe thunderstorm, tornado, and flash flood warnings are issued, having multiple methods to receive these warnings and weather information is very important for you to be able to take the appropriate action. This could include a NOAA weather radio, a reverse call system, television/radio, or nearby sirens if you are outdoors. In addition, you should know what to do when these warnings are issued. Have a plan - and put that plan into action. Make sure you have a safety kit ready to go, as well as a point of contact who can make sure everyone is accounted for and safe.

A Severe Thunderstorm Warning means severe weather (damaging winds at least 60 mph and/or large hail of 1 inch or greater) has been reported by spotters or indicated by the National Weather Service's radar. Take shelter in a substantial building, away from windows. If the severe thunderstorm warning states winds in excess of 80 mph, treat it like a tornado warning.

A Tornado Warning means a tornado has been spotted or indicated by radar. There is imminent danger to life and property. Take action now! Move to the basement or an underground cellar if possible. If an underground shelter is not available, move to an interior room (multiple walls between you and the outside of the house) on the lowest floor of a sturdy building. You should be sheltered well away from windows or any outside doors. The smaller the interior room the better (closet, bathroom, hallway).

A Flash Flood Warning means a flash flood (rapid rise of water) is imminent or occurring and could infringe on property or threaten life. If you are in a flood prone area, move immediately to higher ground. Do NOT try to travel across flooded roadways. Know ahead of time which roads are likely to flood, and what other routes out are available (if any). If water is starting to rise, go ahead and evacuate before it's too late.

Make it a point to practice your severe weather plan. The month of March is a great time to pick a day to simulate that severe weather is happening and to practice your plan with family members and friends so that everyone knows what to do and where to go in an actual severe weather situation.
